Learning Outcomes

Upon successful completion of this course, students should be able to:

Cognitive: know the classification of insects and arthropods more broadly, understand the basic principles of systematics, know a range of behavioural, ecological and applied phenomena as they relate to different insect groups and understand the processes associated with them

Psychomotor: use insect collecting equipment, insect pins, pinning trays and microscope, be able to dissect an insect

Affective: obtain an appreciation of the beauty and academic interest of insects

Experiential Education and E-Learning

The entire laboratory component of this course is experiential education with considerable outdoor, hand-on insect sampling experience.

Slide shows and online videos illustrate the beauty of insects

There is also considerable opportunity for the development of aesthetic appreciation of insects

Other Information

Students will arrive on time as the lectures and laboratories occur in the same space which can be locked from inside as soon as lectures begin

Students who are scared of insects and/or not prepared to spend a considerable amount of time outdoors looking for specimens for their collection (which is worth half the course marks) will not do well.

Students should expect to spend a considerable amount of time outdoors outside of formal class time to obtain the diversity of insect specimens required for success

The professor meets with the students one-on-one at least twice during the course to give direction for the collection and how to do well/better in the class

Course Policies

- Because we give students until the last minute to hand in their collections and chosen insect
 assignment (giving us just enough time to mark them before we have to meet the university
 deadline for assigning marks), late collections and chosen insect assignments cannot be marked.
- Because the course is lab-intensive, missed labs mean that valuable insect identification time is missed.
- There will be no make-up exams.
